If you will be establishing a corporation, S corporation, partnership, or limited liability company, you must register with the Secretary of State.

To conduct any business in Oakland you must first obtain a Business Tax Certificate and pay an annual business tax. The term business includes all commercial and residential rental activities, including single family residences that are rented. For more information, call or visit the Business Tax Section.

Certain types of businesses may require inspections by the Health Department, Police Department, or Fire Prevention & Inspection Department.
